The excursion supports EYLF learning outcomes relating to identity, community connection, wellbeing and communication.

- Guided observation of exhibitions supporting visual literacy and inquiry skills
- Aboriginal and Torres Strait Islander storytelling and cultural appreciation experiences
- Educator-led discussions about culture, history and respectful behaviour in public settings
- Reinforcement of safety boundaries within indoor galleries and outdoor areas
- Group reflection and communication activities encouraging vocabulary development
- Hygiene routines and supervised snack practices where applicable
- Hydration monitoring and rest breaks where required
